Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

The AGAR was not accurately completed before submission for review:

- The responses given in Section 1, Box 9 and Section 2, Box 11 are not consistent. The Council has confirmed that it does act as sole managing trustee for trust funds and thus the answer for Section 2, Box 11 should have been "Yes".
